Bliss Ayurveda processes your personal data because you use my services and / or because you provide them yourself.

Below you will find an overview of the personal data that I process:

Special and / or sensitive personal data that we process

Bliss Ayurveda processes the following special and / or sensitive personal data from you:

- health (naturopathic / ayurvedic)

For what purpose and on what basis we process personal data

Bliss Ayurveda processes your personal data for the following purposes:

- Handling your payment
- Sending the newsletter and / or advertising brochure
- To be able to call or e-mail you if necessary, to carry out my services

- To inform you about changes to my services and products
- To have goods and services delivered to you
- Bliss Ayurveda also processes personal data if I am legally obliged to do so, such as information that I need for my tax return.

Automated decision making

Bliss Ayurveda makes decisions (not, entirely) based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee and Bliss Ayurveda). Bliss Ayurveda uses the following computer programs or systems:

Name of the system: WordPress

Why it is used: website

Why it is used: Print a medical history / diagnosis form and create invoices

Underlying logic, importance and expected consequences for the person concerned: personal data for the services of the practice for Bliss Ayurveda are noted on this to advise on the treatment and to describe the progress of the treatment.

How long we keep personal data

Bliss Ayurveda does not store your personal data longer than is strictly necessary to realise the goals for which your data is collected. I use the following retention periods for the following (categories) of personal data:

Reason: legislation determines a 15-year retention period

Personal details (First and last name, Gender, Date of birth, Place of birth)> 15 years> filing for processing and invoicing

Address (Address details, Telephone number, E-mail address)> 15 years> filing for processing and invoicing

Health (naturopathic)> 15 years> filing for treatment and invoicing

Sharing personal data with third parties

Bliss Ayurveda does not sell your data to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. I conclude a processor agreement with companies that process your data on my behalf to ensure the same level of security and confidentiality of your data. Bliss Ayurveda remains responsible for these processing operations.
